If your sponsorship spot can be filled, we will allocate your funds as credit towards a future 2026 event. If your spot cannot be filled, you have waived your right to a credit. No credit will be given for a cancellation request received less than 14 days prior to any event. 2026 Sponsorship funds MUST be used within the 2026 calendar year. No 2026 sponsorship funds can be carried over to 2027. Unused funds as of December 1, 2026, are considered forfeited to CAM University.
